6. Chairman's Comments:

Regular:

- DOD announced a 1year Survivor Benefit Plan Open Enrollment.
- There are a couple of criteria.
 - 1) If you were in the plan and chose to leave you are not eligible to return.
 - 2) The open enrollment elections require a lump sum "buy-in" premium along with future monthly premiums. The lump sum premium is equal to all back premiums plus interest from the date of original eligibility plus an amount needed to protect the Military Retirement Fund This lump sum can be paid over a 2 year period.
- The VA activated a surviving spouse benefit website: http://www.vba.va.gov/survivors
- New Senior Enlisted Advisor to the Chairman of the Joint Chiefs of Staff position created Command Sgt. Maj. William J. Gainey was selected to occupy the post.
- Unconfirmed reports of gasoline shortages at Beale and Travis AFEES stations.
- Four Air Force Retiree Council positions to become vacant although those selected will not become members until 1 July 06 the new area representatives normally attend the

next Council meeting as observers. The Pacific Region including Alaska and Hawaii is one of the positions becoming vacant. CMSgt. Vincent D. Mee Jr. is leaving.

- 8 Oct 05 the Navy turns 230 years old. A celebration will be held at the Garden Pavilion at McClellan Park, cost \$30 per person.
- VA drivers are still needed at Mather during the weekdays to transport patients from the parking lots to the various clinics. The drivers typically work four hour shifts (8-12, 12-4).
- Del Campo JROTC to be held 17 Nov. at Carmichael Elks Lodge.
- Assemblyman Joe Nation was appointed to Chair of the Assembly Veterans Affairs Committee.
- There was a letter written by the American Legion demanding the resignation of Secretary Johnson because of perceived inaction by the Secretary at the Department of Veterans Affairs. The Armed Forces Retirees Association wrote a letter in support of Secretary Johnson.
