Regular: MSgt (Ret) Michael Grabow introduced Ms. Sue Frost as our guest speaker and introductions were made by members of both Chapters. The introduction included MSgt Grabow reading a recent article in a recent Comstocks magazine about her efforts supporting Veterans. Ms. Frost then spoke about the article discussing how Sacramento County is home to roughly 90,000 veterans, but they have a small voice in local government. Ms. Frost did some digging and discovered that just one seat on more than 100 county boards and commissions was designated for a veteran — a cemetery advisory commission. That was something the Sacramento Board of Supervisors wanted to change. In January, the board created a Veterans Advisory Commission to advise them about veterans' issues. They found that 24% of the homeless were Veterans. Ms. Frost discussed many outreach programs for those in need. Website: http://www.bos.saccounty.net/District4/Pages/default.aspx.
