As of January 2021, the VA had approved disability claims related to burn-pit exposure for 3,442 veterans out of 13,830, according to the latest data from the agency. The American Rescue Plan Act of 2021 signed into law will write off up to \$1 billion in veterans' medical debt. According to the law, all copayments for medical care provided to veterans through the VA from April 6, 2020, to Sept. 30, 2021, will be waived.
