• Chairman's Comments:

- Calendar of Events:
 - a. Feb/Mar Election Support Thanks to all the volunteers. For tax purposes, FICA was deducted from the amount of funds received. If volunteers don't exceed \$600 in the

calendar year the FICA will be refunded. If not, volunteers will need to claim the amount on your 2020 taxes. (Closed)

- MDA Muscle Walk 23 Aug. Due to the COVID19, no meetings have been held and no additional information has been provided. We agreed to providing water and ice. New information will be provided when it is known. (Open)
- c. NCOA Conference 14-17 Jul 20. If it happens, the hotel originally being used will change due to renovations occurring. The conference may be postponed until Sept. Annual bylaws are required and may be done by a ZOOM meeting if the conference is canceled. Financial support was discussed and will be re-visited. (Open)

• Chapter Website:

a. Merchandise was discussed and we will continue looking into providing more details of what is available. Also, there are additional costs for maintaining the website. Ms. Wright will be providing information with the increased costs. (Open)

a. COVID 19 - It continues to change the way we meet and daily life! (Open)

• General Topics:

- a. A motion was made to donate \$250.00 to the Sacramento Stand Down Association. All were in favor of the motion. A check will be provided as soon as possible. (Closed).
